**Fees Payment & Cancellation Policies:**

- 1) No place on the course will be confirmed unless the full fee is received. All fees are required to be paid in full to validate the participation at the course.
- 2) The registration can be cancelled up to two (2) months before the course date (until Thursday, the 8<sup>th</sup> of October 2020) at the latest. However, a minimum administrative charge of €100,00 (administration fee) plus €65,00 (the cost and the postal expenses of the textbook) to be deducted from fees paid + the bank transfer charges. For payments by credit card a handling fee of 3.5 % of the paid course fee will be restrained.
- 3) In case of cancellation within the following period: 09<sup>th</sup> of October 2020– 09<sup>th</sup> of November 2020 (32 day period), a 50% of the paid full course fee will be restrained, that is €445,00.
- 4) In case of cancellation on and after the 10<sup>th</sup> of November 2020 (less than a 28 day period before the course commencement) will incur the loss of the whole fee (100%). Same goes for non – attendance or cancellation after the program commences. Withdrawals are not refundable (course and/ or re-sit examination).
- 5) If the theory mark at the Introductory exam is below 60%, the candidate will not be able to take the Certified exam and he/ she will receive back the amount of €210,00 (fees for certified exam first attempt).
- 6) Candidates who score higher than 60% passing grade on the Introductory exam, they automatically sit the Certified exam on the same day. In case a student decides to withdraw from the certified examination, although being successful at the introductory exam, W.S.P.C. maintains the right to fully examine any consequent refund request and to notify the student for the outcome within 5 working days.

**Terms and Conditions:**

- Enrolment is open to any persons who are 18 years old or over.
- It is an advantage that all candidates have an appropriate amount of Service experience within the Hospitality industry working with Wine & Beverages.
- At the Certified MS Exam can be sited only (is only offered to) those who have successfully completed the Introductory CMS Course & Exam. That is why is so important/ essential to complete your registration ASAP and start studying!
- Those who have successfully completed the Certified MS Exam are entitled to enrol to the Advanced MS Course & Examination.
- Consequently, applicants for the MS Diploma must have successfully completed the CMS Advanced Certificate.
